

## MINUTES OF THE JUNE 19, 2019 BOARD OF HEALTH MEETING



## Call to Order:

The June 19, 2019 Regular Meeting of the Board of Health was called to order at 6:39 pm by Chairperson Colleen Labow.

Board member Labow answered no they will not be effected. Derrick noted it potentially could affect animal control but not the other shared services.

Colleen requested waiving the application fee for a temporary food permit one time for the food trucks at the fiftieth anniversary of the Mt Olive Baseball Association event at Turkey Brook on June 22, 2019 from 4:00pm to 9:00pm.

The temporary food permit fee was waived one time on a motion by Dr. Wallack and second by Hawkins; all present were in favor.

Attorney Peter King recognized Karen Blumenfeld, Executive Director, NJ G.A.S.P. Karen noted NJ G.A.S.P. is a non-profit organization started over 40 years ago in Summit, New Jersey. The original goals and objectives was to get smoke away from non-smokers. The current focus is on identifying immerging trends and issues on tobacco control. Ms. Blumenfeld provided several ordinances for an example of how surrounding towns have handled tobacco and vaping. Mr. King asked Ms. Blumenfeld if she would look at Mt. Olive's current tobacco ordinance and provided feedback.

Board member Cooper went to Hoboken to research how the retail establishments and residents were adapting to the plastic bag ordinance. She said both had no complaints and seemed to be working well. She also went to Starbucks and found paper straws were being used. The consensus was that people conformed quickly without a lot of objection.
