To improve the safety of our pedestrians and drivers on Wolfe Road near the Mount Olive Middle School, Chief Michael T. Spitzer, in partnership with Mount Olive Township and the Mount Olive Township School District, jointly announce that new *Emergency Roadway Restrictions* will be temporarily implemented, effective Monday, April 22, 2024, until at least the end of the 2024 school year. Specifically, in addition to the existing parking restrictions enforceable on Wolfe Road under Township Code, § 375-21 - Parking prohibited at all times, the below Emergency Roadway Restrictions (See Map Below) shall be implemented as per Township Resolution #166-2024 at the April 16th Council meeting and as described below.

Authorizing a trial program prohibiting vehicles from stopping and standing on Wolfe Road (Northbound) between Flanders-Drakestown Road and Kings Arrow Road during school zone hours, to reduce traffic congestion.

The Police Department conducted a traffic study during March to investigate the congestion and safety concerns in front of the Middle School on Wolfe Road. It is recommended, on a trial basis through the end of the school year, to temporarily prohibit vehicles from stopping and standing on Wolfe Road, from Flanders-Drakestown to Kings Arrow Road, during school hours.
