In addition to providing local medical transportation, our buses transport seniors to the Senior Center for Nutrition on Monday, Wednesday, and Friday. The price of the hot lunch is a suggested \$2.00 donation. Our seniors enjoy socializing before and after lunch with various activities. If you are planning on attending the Nutrition program, please call Tanya prior to attending at (973) 448-7474 to reserve a meal. Food shopping to Weis and ShopRite is offered once a week, generally on Thursday. We also plan a special monthly trip, usually on the last Tuesday of the month. In the past we have gone to Rockaway Mall, Cracker Barrel, Red Lobster, and more.

We also transport seniors to the bi-monthly Senior Meeting. Senior Meetings are held at the Senior Center on the first and third Tuesdays of the month. The annual dues to become a member of the Mount Olive Senior Club are \$15.00. The Mount Olive Senior Center is open Monday through Friday from 8:30 a.m. until 4:30 p.m. for Senior Club member use. Please keep in mind that Senior Center events are open to Mount Olive Township Senior Club members regardless of your transportation needs. ### Senior Transportation Guidelines

#### Participation:

Senior transportation is a **curb to curb** service mainly for seniors with no other means of transportation. These persons will be given first priority with regard to scheduling.

Seniors who have a valid driver's license and own a vehicle but are temporarily unable to drive will also be considered.

Seniors who have a valid driver's license and own a vehicle and are capable of driving will be considered if seats are available.

#### Requirements:

Must be a resident of Mt. Olive, Flanders, or Budd Lake and 60 years of age or older and be registered with the township.

Residents 18-59 years of age who are physically disabled or handicapped are eligible to register. Disabled residents must obtain a certification form (provided by us) to be filled out by a doctor and returned to us.

Residents requiring transportation for mental health counselling will need to provide documentation from their doctor stating they pose no threat to others.

## **Reservations:**

Rides are available starting at 9:00 am with return pick up no later than 3:00 pm on weekdays. **ALL medical reservations must be called in at least 1 week in advance before 4:30 pm. Please call as soon as you get your appointment as time slots fill up fast. Passengers must be flexible in regard to pick up times.** If you leave a message, please make sure to call back and speak with someone to confirm your appointment.

## **RESERVATIONS CANNOT BE MADE WITH DRIVERS**

## **Passenger Requirements**

For smoother and safer service to all, the following are required:

Passenger aisles on the vehicle must be kept clear at all times.

Verbal abuse of staff or passengers will not be tolerated.

Physical abuse or threatening of staff or passengers will not be tolerated.

Smoking on any vehicle is prohibited.

Please be advised that the acceptance of gifts, money or any type of gratuity by the driver is strictly prohibited.

Eating and drinking are prohibited in the vehicles.

Alcohol or any illegal substances are prohibited.

Passengers must follow the driver's instructions.

Passengers must respect and maintain the private, personal space and wishes of the drivers and other passengers.

Passengers must remain seated and have seatbelts engaged while in the vehicle.
