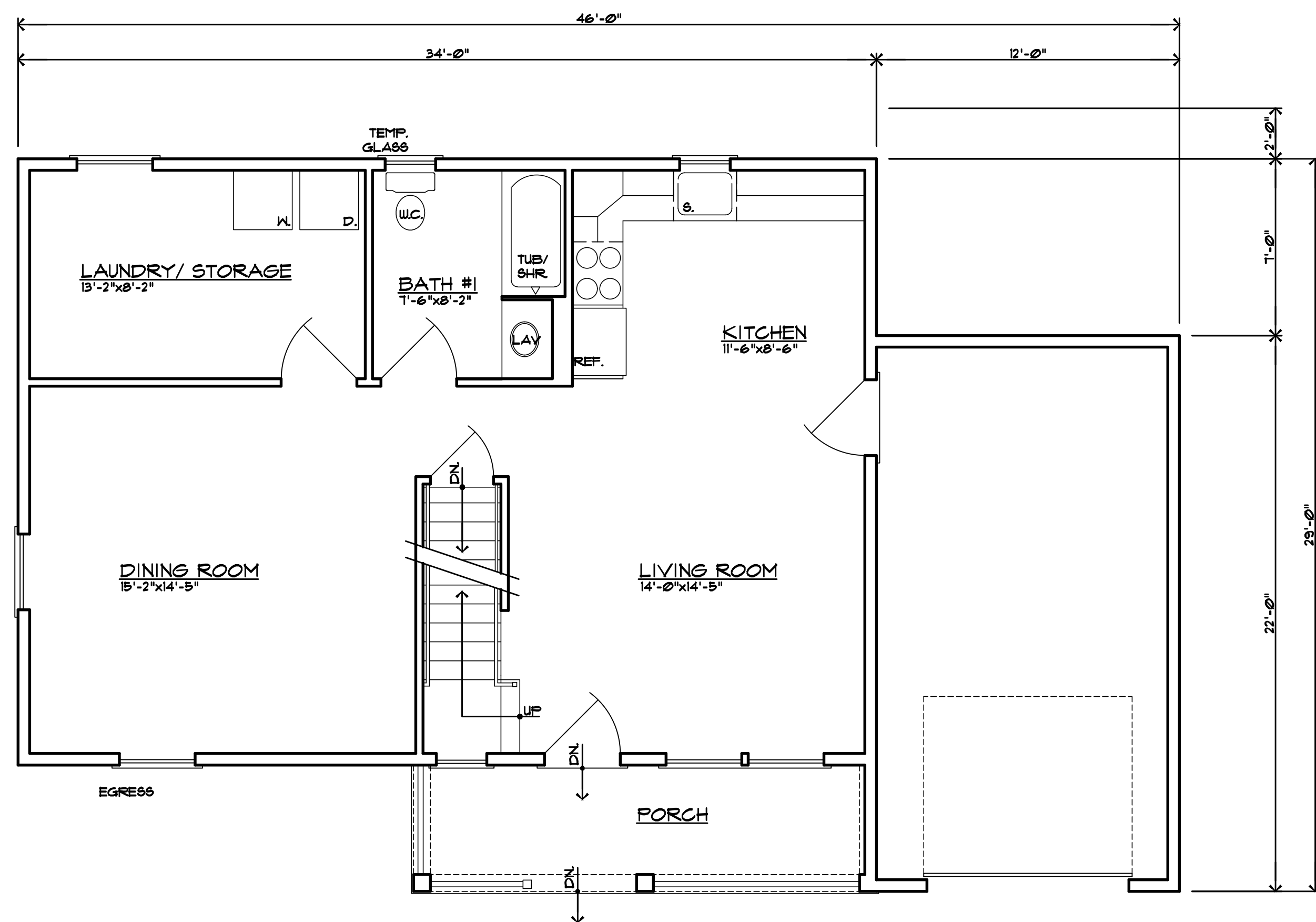

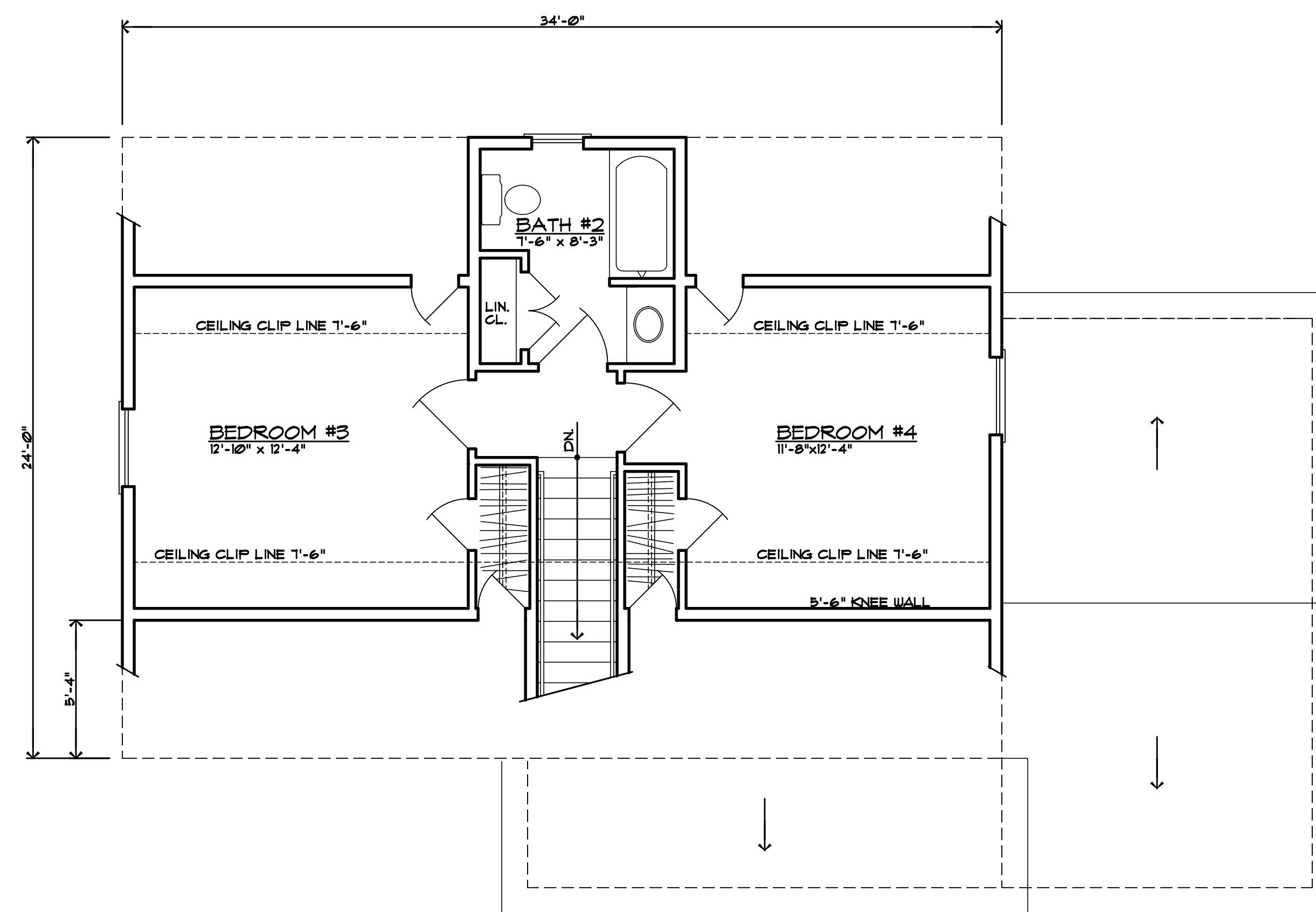



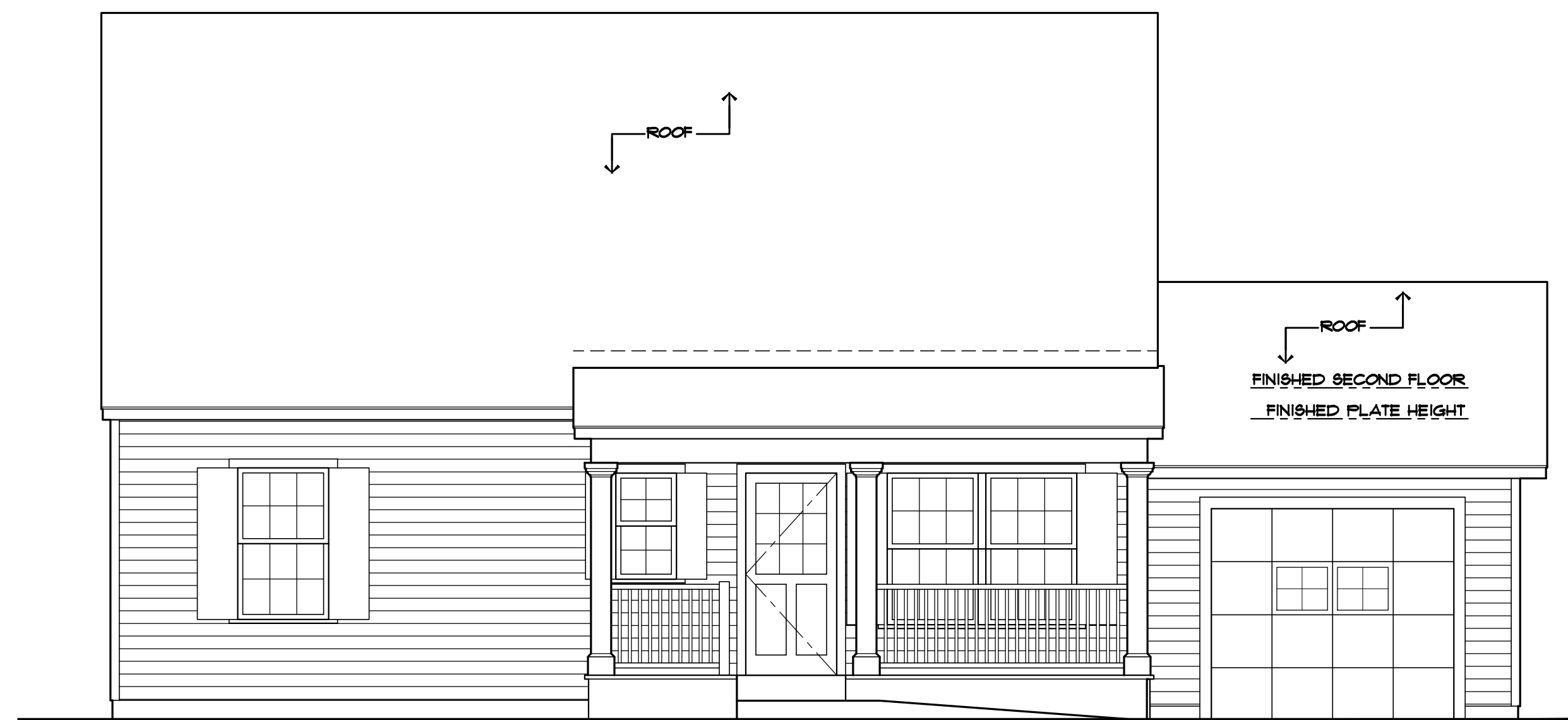

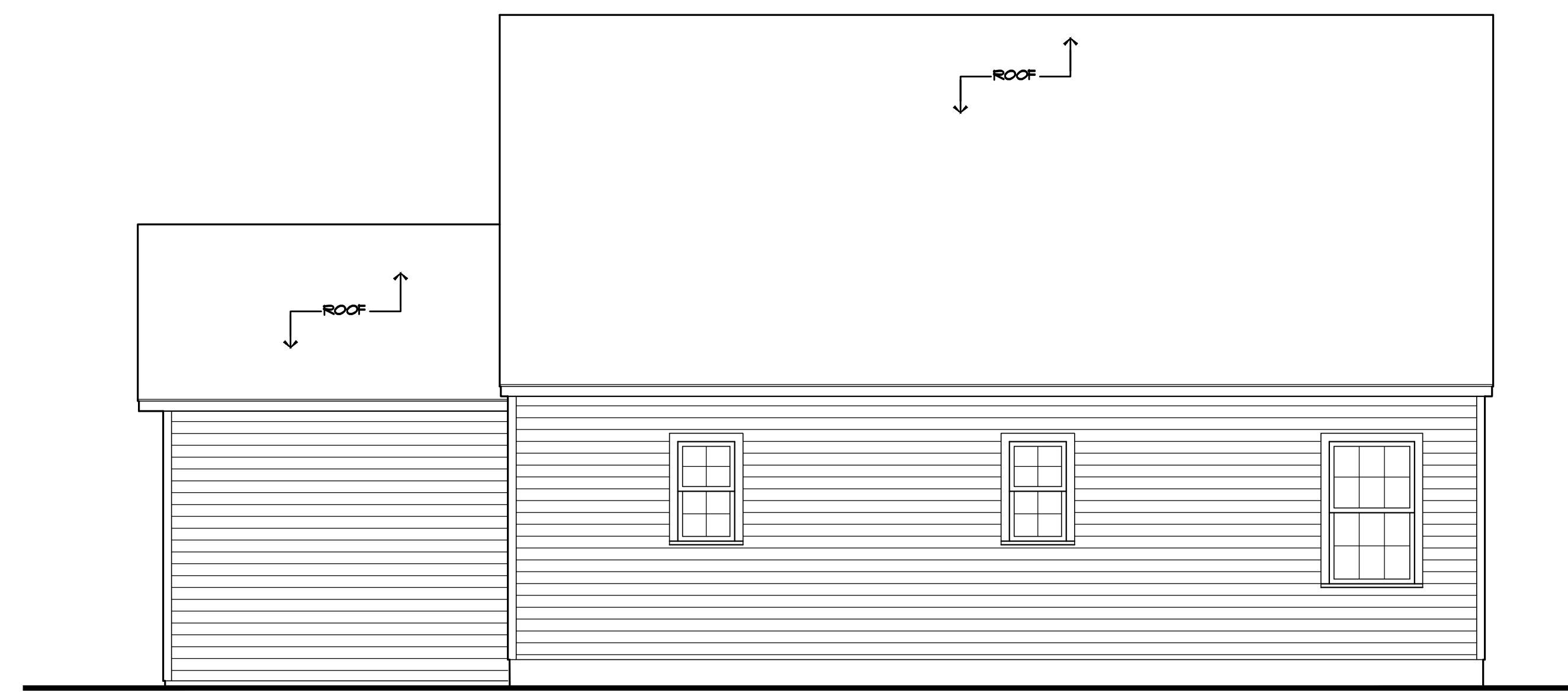
**PROPOSED FRONT ELEVATION**
