

ORDINANCE AMENDING SECTIONS 3(j), 3(m) AND 3(o)(2) OF
BOND ORDINANCE #5-2016 OF THE TOWNSHIP OF MOUNT
OLIVE, IN THE COUNTY OF MORRIS, NEW JERSEY, FINALLY
ADOPTED MARCH 18, 2016, AS AMENDED BY ORDINANCE
#22-2016, FINALLY ADOPTED OCTOBER 4, 2016 IN ORDER TO
AMEND THE DESCRIPTION OF THE PROJECTS.

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MOUNT
OLIVE, IN THE COUNTY OF MORRIS, NEW JERSEY (not less than two-thirds of all members
thereof affirmatively concurring) AS FOLLOWS:

Section One. Section 3(j) of Bond Ordinance #5-2016 of the Township of Mount Olive, in
the County of Morris, New Jersey (the "Township"), finally adopted March 8, 2016, as amended by
Ordinance #22-2016, finally adopted October 4, 2016 (Bond Ordinance #5-2016), is amended to
include the acquisition of aerators as follows:

"j) Recreation Department:

The acquisition of portable light towers, golf carts, ice eaters and aerators, including all
related costs and expenditures incidental thereto."

Section Two. Section 3(m) of Bond Ordinance #5-2016 is amended to include general park
improvements as follows:

"m) Various Sports Groups:

Repair and replacement of volleyball and basketball courts and general park
improvements, including all work and materials necessary therefor and incidental
thereto and further including all related costs and expenditures incidental thereto."

Section Three. Section 3(o)(2) of Bond Ordinance #5-2016 is amended to include general
camera improvements and purchases as follows:

"o) Buildings and Grounds:


2) Security improvements and general camera improvements and purchases, including
all related costs and expenditures incidental thereto."

Section Four. All other details of Bond Ordinance #5-2016 remain as originally adopted.

Section Five. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section Six. This ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.
