

MINUTES OF THE JANUARY 19, 2022 BOARD OF HEALTH REORG AND REGULAR MEETING



Call to Order:

The January 19, 2022 Reorganization and Regular Meeting of the Board of Health was called to order at 6:35 pm by Chairperson Colleen Labow. The meeting was held via video conferencing (Zoom).

Open Public Meetings Act Announcement:

The Board Secretary made the following announcement:

The Chairperson recognized; Deputy Director/Assistant Health Officer, Derrick Webb; Board of Health Secretary, Michele Doucette; and Attorney, Peter King. Health Officer, Trevor Weigle was absent.

Review of the Minutes:

The minutes of the December 15, 2021 Board Meeting were approved on a motion by Dr. Abrams and second by Colleen Labow; all Members present were in favor.

Written Reports & Correspondence:

The Deputy Director/Assistant Health Officer reviewed the Public Health Activities Report for December 2021. He noted the 2021 YTD total for OPRA requests was 499. He also noted that December had the highest COVID cases in a month at 1,335 and the YTD total was 3,448. Board Member Abrams asked about the circumstances on the vicious dog case. The Deputy Director/Assistant Health Officer noted that he would email each member the specifics regarding the case.

Board Member Miccio asked why Dover decided not to continue with MOT public health services. The Deputy Director/Assistant Health Officer noted that they did not give any specific reason.

RESOLUTION BOH 2022-08

RESOLUTION AUTHORIZING THE AWARD OF A PROFESSIONAL SERVICES CONTRACT – BOARD ATTORNEY

WHEREAS, there exists a need for legal services; and

WHEREAS, the Local Public Contracts Law (*N.J.S.A.* 40:11-1, *et seq.*) requires that a resolution authorizing employment for "Professional Services" without competitive bids must be publicly advertised; and

WHEREAS, the Business Administrator of the Township of Mount Olive has determined and certified in writing that the value of the acquisition will exceed \$17,500.00; and

WHEREAS, Peter J. King, LLC, of the law firm of King Moench Hirniak & Mehta, LLP, has completed and submitted a Business Entity Disclosure Certification which certifies that Peter J. King, LLC has not made any reportable contributions to a political or candidate committed in the Township of Mount Olive in the previous one year, and that the contract will prohibit Peter J. King, LLC from making any reportable contributions through the term of the contract.

NOW, THEREFORE, BE IT RESOLVED, that Board of Health of the Township of Mount Olive, County of Morris, New Jersey, agrees as follows:

1. That a Contract is awarded to Peter J. King, LLC for the legal services hereinafter specified for the period commencing January 1, 2022 through December 31, 2022.

2. This Contract is awarded without competitive bidding as "Professional Services" under the provisions of the Local Public Contracts Law because these services are professional and it is not possible to obtain competitive bids.

3. The Business Entity Disclosure Certification and the Determination of Value Certification shall be placed on file with this Resolution.

4. That a Notice of this action be published in accordance with law. Said Notice to provide that the Contract is awarded and this Resolution authorizing same are available for public inspection in the office of the Township Clerk and in the Board of Health Office.

5. This Contract is being awarded subject to the availability of funds.

RESOLUTION BOH 2022-09

RESOLUTION OF THE BOARD OF HEALTH OF THE TOWNSHIP OF MOUNT OLIVE AUTHORIZING AN INTERLOCAL SHARED HEALTH SERVICES AGREEMENT BETWEEN THE BOARD OF HEALTH OF MOUNT OLIVE AND THE BOARD OF HEALTH OF THE TOWNSHIP OF MINE HILL PURSUANT TO THE UNIFORMED SHARED SERVICES AND CONSOLIDATION ACT, N.J.S.A. 40A:65-1, ET SEQ., AND N.J.S.A. 26:3A2-1, ET SEQ.

WHEREAS, the Board of Health of the Township of Mine Hill has requested that the Health Department of the Township of Mount Olive furnish to the Board of Health for the Township of Mine Hill, shared health services as set forth in *N.J.S.A.* 26:3A2-1, *et seq.* and *N.J.S.A.*40A:65-1, *et seq.*; and

WHEREAS, based on the discussions and agreement between the Township of Mount Olive Township Administrator and the Health Officer and the Township of Mine Hill, the Board hereby authorizes an interlocal health services agreement between the Board of Health of the Township of Mount Olive and the Board of Health of the Township of Mine Hill for the purpose of establishing the aforementioned interlocal agreement for shared health services; and

WHEREAS, said Agreement is for shared services to be provided for the calendar years 2022, 2023, and 2024, respectively.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Health for the Township of Mount Olive, that a Uniform Shared Services Agreement between the Board of Health hereby of the Township of Mount Olive and the Board of Health of the Township of Mine Hill is authorized and fully endorsed (by its members) for the Health of the Township to proceed with this Agreement.

BE IT FURTHER RESOLVED, that a copy of this Resolution and the Uniform Shared Services Agreement be forwarded to the Mount Olive Township Council for approval based on the Boards' recommendation that the Agreement be executed.

BE IT FURTHER RESOLVED, that a notice of this action shall be printed once in the legal newspaper of the Board of Health as required by law.
