



## **MINUTES OF THE APRIL 21, 2021 BOARD OF HEALTH MEETING**



### **Call to Order:**

The April 21, 2021 Regular Meeting of the Board of Health was called to order at 6:34 pm by Chairperson Colleen Labow. The meeting was held via video conferencing (Zoom).

### **Review of the Minutes:**

The minutes of the March 17, 2021 Board Meeting were approved on a motion by Board Member Wallack and second by Hawkins; all members present were in favor.

### **Written Reports & Correspondence:**

The Health Officer reviewed the Public Health Activities Report for March 2021. The Health Officer also updated the Board of Health on the pandemic with an excel spreadsheet showing the numbers of cases, number of cases still in isolation, and the number of deaths to date.

The Health Officer noted a blood screening clinic was potentially being scheduled for the end of May using a voucher system.

The Public Health Activities Report for March 2021 was approved on a motion by Board member Abrams and second by Wallack: all members present were in favor.

RESOLUTION OF THE BOARD OF HEALTH OF THE TOWNSHIP OF MOUNT OLIVE AUTHORIZING AN INTERLOCAL SHARED HEALTH SERVICES AGREEMENT BETWEEN THE BOARD OF HEALTH OF MOUNT OLIVE AND THE BOARD OF HEALTH OF THE TOWN OF DOVER PURSUANT TO THE UNIFORMED SHARED SERVICES AND CONSOLIDATION ACT, N.J.S.A. 40A:65-1, ET SEQ., AND N.J.S.A. 26:3A2-1, ET SEQ.

**WHEREAS**, the Board of Health of the Town of Dover has requested that the Health Department of the Township of Mount Olive furnish to the Board of Health for the Town of Dover, shared health services as set forth in *N.J.S.A. 26:3A2-1, et seq.* and *N.J.S.A.40A:65-1, et seq.*; and

**WHEREAS**, based on the discussions and agreement between the Township of Mount Olive Health Officer and the Town of Dover Administrator, the Board hereby authorizes an inter local health services agreement between the Board of Health of the Township of Mount Olive and the Board of Health of the Town of Dover for the purpose of establishing the aforementioned inter local agreement for shared health services; and

**WHEREAS**, said Agreement is for shared services to be provided for the calendar years 2021 and 2022, respectively.

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Health for the Township of Mount Olive, that a Uniform Shared Services Agreement between the Board of Health of the Township of Mount Olive and the Board of Health of the Town of Dover is authorized and fully endorsed (by its members) for the Health Officer of Mount Olive Township to proceed with this Agreement.

**BE IT FURTHER RESOLVED** that a notice of this action shall be printed in the legal newspaper of the Board of Health as required by law.

The Resolution was approved on a motion by Board member Hawkins and second by Wallack; all present were in favor.
